Petition Circulator Information

Thank you for being a leader and taking back Los Angeles from the failed leadership that is destroying our City. _The Petition to Recall Los Angeles Mayor Antonio Villaraigosa is a legal document approved by the City's Election Clerk and therefore, there are specific rules petition circulators must follow or the signatures you gather will not qualify.

Petition circulators must be at least 18 years of age and qualified to vote in the state of California. Signatures must come from persons registered to vote in the City of Los Angeles._There are 7 spaces for each qualified signer to complete, one of which is optional. The Los Angeles registered voter must:

1. Print their name,
2. Sign their name,
3. Print their residential street address as recognized by the LA County Registrar/Recorder (Election Office) – no P.O. boxes,
4. Print city,
5. Print zip code,
6. Print the date they signed,
7. Birthdate is optional if their name is common enough that the birthdate would clarify who the signer is.

The signer must fill out all spaces him/herself. If any of the spaces are left blank or are unreadable, that signature is disqualified. Please direct the signer to fill out each space correctly. Look over each signature line to ensure you gather all the necessary information.

Only **after** you complete your petition with signatures do you complete the "Affidavit Of Circulator." If you sign the affidavit before you gather the signatures, your petition will be disqualified. Please read the affidavit; it informs you of your legal obligations. You only need to fill out one of the two affidavits - English or Spanish.

To trigger a Recall Election of Mayor Antonio Villaraigosa we must gather nearly 250,000 qualified signatures within 120 days starting April 20, 2010. Please do not hesitate to contact us if you have any questions about gathering qualifying signatures.

STATEMENT OF REASONS FOR PROPOSED RECALL

We, the undersigned voters of the City of Los Angeles do hereby petition The Los Angeles City Clerks Office for redress of our grievances and do hereby request a Recall Election to be held - for cause - against Mayor Antonio Villaraigosa. Mayor Villaraigosa has continually ignored the warnings of City financial officers for several years. He is a direct cause of the current financial crisis.

Despite record income over the last five years, Mayor Villaraigosa has led the City down a path of reckless and irresponsible spending that would have been avoided by a more professional and competent City Official.

In the face of a crushing recession, the Mayor actually accelerated spending and hiring to the point that the City may have to declare BANKRUPTCY before the end of 2010. While he is now asking City officials to eliminate thousands of City jobs, the Mayor has selfishly refused to fire a single member of his enormous staff - including 16 Deputy Mayors and 93 personal staff members.

Mayor Villaraigosa is now planning to have the DWP enact a "Carbon Fee" to increase rates to help cover the massive City deficit and to pay for the excessive pay raises given to DWP employees.

Voters of this City cannot afford 3 more years of this. His efforts so far have brought about job losses and financial ruin.

EXPOSICIÓN DE MOTIVOS PARA LA DESTITUCIÓN PROPUESTAS

Nosotros, los abajo firmantes votantes de la Ciudad de Los Ángeles por la presente pedimos a la Oficina del Secretario de la Ciudad de Los Ángeles la reparación de nuestros agravios y por este medio solicitamos que se celebre una elección de Destitución - con causa - contra el Alcalde Antonio Villaraigosa.

El alcalde Villaraigosa ha ignorado continuamente las advertencias de los funcionarios financieros de la Ciudad por varios años. Él es una causa directa de la crisis financiera actual.
